# Discussion:

 Commissioner Anderson addressed the court on the interlocal agreement with the City of Melvin has not been renewed since 2018 to maintain streets and roads. She is working with the City of Melvin Mayor to get an Agreement worked out between them and the County and will present to the Court once it is done.

## Action:

- 2. The Court acted and approved Mrs. Sheridan Hosid as the new Library Director. Commissioner Deans made the motion and Commissioner Anderson seconded. All in favor Motion carried. 5-0
- 3. The Court approved the 2021 McCulloch County Library Advisory Board Members presented by Nancy Gordon. Commissioner Anderson made the motion with Commissioner Behrens seconded. All in favor Motion carried. 5-0
- 4. Commissioner Anderson received only one bid on the 2000 Mack Truck and 1964 Belly Dump trailer. She was very disappointed about getting only one bid and wanted to explore other avenues and options to get out to the public when items, news and equipment are opened up for bids. Commissioner Anderson and the court accepted the one bid received from Sterling Moore for \$9,000.00 for the Mack Truck and \$3,000.00 for the Trailer. Commissioner Deans made the motion with Commissioner Behrens seconded. All in favor Motion carried. 5-0
- 5. The Court accepted and approved the Resolution opposing the Unfunded Mandates from the State of Texas. Commissioner Anderson made the motion with Commissioner Deans seconded. All in favor Motion carries. 5-0
