All in favor Motion carries. 5-0 Minutes from August 14, 2023 were presented and approved with Commissioner Anderson making the motion and Commissioner Deans seconded. - The Court discussed, acted, and approved the Order for the 2023 General Election for November 7, 2023. Commissioner Deans made the motion with Commissioner Behrens seconded. All in favor Motion carries. 5-0
- 6. The Court received the annual McCulloch County Child Welfare Board report from Gina Murray.

 Mrs. Murray thanked the County for its contributions and continual support. Commissioner Deans made the motion and Commissioner Bratton seconded. All in favor Motion carries. 5-0.

- 7. The Court heard from Chief Deputy Jason Corbell on the Annual Sheriff's Fees. There will be no change from last year. Commissioner Deans made the motion to accept and approve the fees with Commissioner Bratton seconded. All in favor Motion carries. 5-0.
- 8. The Court discussed, acted, and approved a pre-adjudication detention service agreement between the Guadalupe County Juvenile Board(Guadalupe County Juvenile Services) for the term of October 1, 2023 through September 30, 2024. Commissioner Behrens made the motion and Commissioner Anderson seconded. All in favor Motion carries. 5-0.
- The Court discussed, acted, and approved the Taylor County Juvenile Justice Center contract and agreement between Taylor County(Taylor County Juvenile Justice Center) and McCulloch County for the term of 2024. Commissioner Anderson made the motion and Commissioner Deans seconded. All in favor Motion carries. 5-0.
- 10. The Court discussed, acted, and approved the Contract and Agreement for Detention of Juvenile offenders between Brown County (Ray West Juvenile Justice Center) and McCulloch County for the term of September 1, 2023 through August 31, 2024. Commissioner Behrens made the motion and Commissioner Bratton seconded. All in favor Motion carries. 5-0.
- 11. The court discussed, acted, and approved the Contract for Detention Services between Tom Green County Juvenile Detention Center and McCulloch County for the term of September 1, 2023 through August 31, 2024. Commissioner Behrens made the motion and Commissioner Bratton seconded. All in favor Motion carries. 5-0.
- 12. The Court discussed, acted, and approved allocating \$15,116.53 from the CSLFRF funds to replace a water tank on the Lohn Volunteer Fire Department Truck #5. Commissioner Deans made the motion and Commissioner Anderson seconded. All in favor Motion carries. 5-0.
- 13. The Court discussed, acted, and approved re-allocation of CSLFRF funds in regards to the Lohn Volunteer Fire Department request for \$15,116.53 for a replacement water tank on Truck #5.
