RESPONDING TO A TRAFFIC TICKET

If you do not want to appear in court: If you do not want to appear in court then you have the option of paying the fine by mail or by paying in person at the court where the ticket has been filed. On or before the appearance date, you can mail or bring to the court the plea form (found on bottom) and the amount of the fine shown below. If fine is not found, call the number above.

If you want to plead NOT GUILTY and request a trial: If you wish to enter a plea of NOT GUILTY and desire a trial, you must so indicate in the proper space provided on the bottom of this form. Return this letter with your plea to Justice Court no later than your appearance date shown on the bottom of your citation. You will be notified by mail of the date of trial. Indicate whether you wish a trial by jury or trial before the judge. You have the right to a trial by jury if you so request.

Failure to Appear on Court Date: If you fail to respond to this charge by the appearance date shown on your citation, the court may issue a warrant for your arrest, suspend renewal of your driver's license and charge you with an additional offense for "Violation of Promise to Appear".

****A conviction of an offense under a traffic law of this state may result in the assessment on your driver's license of a SURCHARGE UNDER THE DRIVER'S RESPONSIBILITY PROGRAM****
