3. FY 2027 Budget / FEMA Workshop

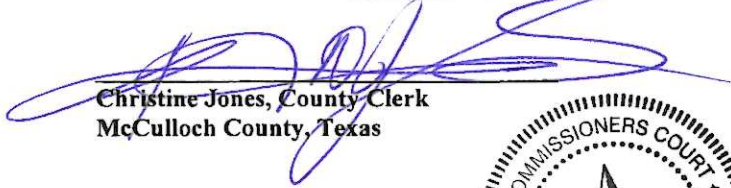
