4. Consider and act on approving the reallocation of CSLFRF funds due to the approval of CSLFRF funds for the Rochelle Volunteer Fire Department-Judge Trull
5. Consider and act on approving an interlocal agreement between the Regional Public Defender Office Local Government Corporation and McCulloch County to provide court appointed counsel for indigent individuals charged with the offense of capital murder-Judge Trull


