**Invocation was given by Commissioner Young followed by the Pledge to the U.S. and Texas Flags.**

**Public Comment:**

**MINUTES:**

Minutes from September 22, 2025, were presented and approved with corrections. Commissioner Deans made the motion and Commissioner Anderson seconded. All in favor Motion carries. 4-0. Commissioner Maricle abstained.

**BILLS:**

Bills for October 14, 2025, were presented and approved. Commissioner Deans made the motion and Commissioner Young seconded. All in favor Motion carried. 4-0. Commissioner Maricle abstained.

**Elected Officials/Department Heads:** Commissioner Deans reported contacting several landowners in his precinct regarding disaster clean up via phone calls and emails. He noted assistance from TetraTech and that progress is slowly being made. Commissioner Anderson stated that there was confusion with the advertisement for debris cleanup and requested updates to include key points. She also reported that Tony Bucholtz inspected the AgriLife building and provided an estimate for repairs. Additionally, she received calls from landowners regarding the proposed battery storage facility of South St. Commissioner Young reported that a representative from Tilson Homes contact him regarding septic tank permits for precinct 3 barn.

**ACTION:**

1. The Court acted and approved the bond for Gary Maricle for McCulloch County Commissioner Pct. #4 as directed by Texas Local Government Code 81.002. Commissioner Deans made the motion with Commissioner Young seconded. All in favor Motion carries. 4-0. Commissioner Maricle abstained
2. The Court acted and approved the request from Daniel Mendoza Chamber of Commerce Director for the use of the County Courthouse Lawn for Christmas in the Heart & Parade of Lights activities. Mr. Mendoza informed the court that the event will be happening on December 13<sup>th</sup>, 2025 beginning at 5:00 p. on the East Side of the Courthouse and he has requested to TxDot to close the whole square by 6:45 to 10:00 pm for the parade. Commissioner Young made the motion with Commissioner Deans seconded. All in favor Motion carries. 5-0.
3. The Court took NO ACTION on a way to bring Nancy Munetake Veterans Service Officer to McCulloch County full time w/pay or help with travel gas and travel. Commissioner Anderson made the motion to take NO ACTION with Commissioner Deans seconded. All in favor Motion carried. 5-0
4. The Court acted and approved on determining the manner to fill the position of McCulloch County Veteran Service Officer part time position. They will accept a job application from Nancy Munetake for the part time position and offer her the position. Commissioner Anderson made the motion with Commissioner Deans seconded. All in Favor Motion Carries. 5-0



5. The court acted and approved a Resolution to apply for the FY 2026 indigent Defense Formula Grant Program. Commissioner Young made the motion to approve the Resolution with Commissioner Maricle seconded. All in favor Motion carried. 5-0
6. The Court acted and approved a Facebook page/account to establish an informational resource for the Citizens of McCulloch County. Commissioner Deans made the motion with Commissioner Anderson seconded. All in favor Motion carries. 5-0.
7. The Court acted and approved with a date change on an Interlocal Agreement between the Texas Division of Emergency Management and McCulloch County to allow use of the premises located at 2941 CR 100, Brady, Tx to stage, sort, and dispose of flood debris. Commissioner Deans made the motion and Commissioner Young seconded. All in favor Motion carries. 5-0.
8. The Court acted and approved on nominations for three McCulloch County Appraisal District Board of Director Positions. Commissioner Anderson made the motion with Commissioner Deans seconded. All in favor Motion carries. 5-0.
9. The Court acted and approved an Interlocal Agreement for Election Services between McCulloch County and the City of Brady. Commissioner Deans made the motion with Commissioner Young seconded. All in favor Motion carries. 5-0.
10. The Court acted and approved on the signing of "Addendum 6" between McCulloch County and Local Government Solutions, L.P. to allow additional user access for the County Attorney's office. Commissioner Maricle made the motion to approve "Addendum 6" with Commissioner Young seconded. All in favor Motion carries. 5-0.
11. The Court acted and approved the HAVA (Helping America Vote Act) Grant Resolution with the Secretary of State for electronic poll pads. Commissioner Anderson made the motion with Commissioner Maricle seconded. All in favor Motion carries. 5-0.
12. The Court acted and approved to go into Closed Executive Session pursuant to Government Code Chapter 551 Section 551.071 consultation with the County Attorney regarding property insurance coverage on the courthouse. Commissioner Deans made the motion with Commissioner Anderson seconded. All in favor Motion carries. 5-0.


