Open Public Hearing on the McCulloch County FY 2022-2023 Proposed Tax Rate was called at 5:17 p.m. The Court waited the allotted time period and Closed the Public Hearing on the McCulloch County FY 2022-2023 Proposed Tax Rate at 5:32 p.m. with Commissioner Anderson making the motion and Commissioner Behrens seconded. All in favor Motion carries. 5-0
2. The Court considered and acted on approving an Order setting the Tax Rate for FY 2022-2023 pursuant to Texas Tax Code 26.05(b)(1) Commissioner Behrens made the motion that the property tax rate be increased by the adoption of a tax rate of .7504 effectively an 8.48% increase in the tax rate. Commissioner Anderson Seconded.


All in favor Motion carries. 5-0
