


**Action:**

2. The Court reviewed and approved the FY 2024 SAVNS Grant Contract between the Office of the Attorney General and McCulloch County for the statewide Victim Notification Service. This will be on the States FY. Commissioner Behrens made the motion and Commissioner Bratton seconded. All in favor Motion carries. 4-0.
3. The Court discussed, acted, and approved the Resolution authorizing the Texas Department of Agriculture Texans Feeding Texans and Home Delivery Meal Grant program for year 2024.
