Judge Trull informed the court that the phone in the elevator does not work due to recent phone upgrade. Snider IT hopefully by next month can determine the billing issue and fix it similar to how they fixed the fire alarm issue.

Judge Trull reported to the court that a permanent fix for the leaky roof at the County Clerk's office needs to be done. Snider IT cannot finish the repairs for the last time that water damaged the office equipment until the county feels the repair is permanent.

Judge Trull reported that he sent a text to Matt Richardson about the roof repair at the extension office but has not gotten a reply yet. The last repairs done on the boilers at the courthouse seem to have fixed the problem of the boilers not staying on. Judge Trull had the annual chiller evaluation done and there will be some repairs done to the oldest chiller.
