Elected Officials/Department Heads: Commissioner Deans reported that sealant at the County Clerk/Tax Assessor office and awning had been repaired, but according to Heart of Texas Roofing, water is still getting through the roof. He will contact the company that did the seal coat on the roof to see if they have any recommendations to offer and expects to have some documentation by the next Commissioner Court meeting.

County Judge also let the court know that the sealant that was used on the County Clerk/Tax Assessors old roof caused the office to have to be shut down early. Commissioner Anderson confirmed as she came to the office to check on the odor.

Commissioner Anderson reported that TxDot wants the commissioners to move surplus material of 104, 77, 294, and 120 tons. Commissioner Anderson will let her part go but would take the surplus at Hwy 87 and 71 if no one wants that material. Commissioner Anderson also reported on her attendance at the West Texas Training for County Judges and Commissioners. She informed the court of the unit road system and would like to know if the court would like a workshop to discuss the possible change to unit road system for McCulloch County. Commissioner Anderson thinks it would be a more cost-effective system for the County.

County Judge Trull reported to the court that Pierce Air Conditioning has begun replacing the two HVAC units at the old jail.
