Elected Officials/Department Heads: County Treasurer Mikkie Williams reported to the court that mapping issues within the software was the cause of problems with balance issue between reports. Commissioner Anderson reported that she was contacted by Mark Mosely with the Burn Association and they are trying to coordinate a public meeting for burn pile training. They tentatively set the date for June 20, 2025. Commissioner Anderson also reported to court that at the last FEMA meeting they are reviewing our motor grader lease purchase agreement to determine the amount of reimbursement that will be allowed for Pct. #4.

County Judge reported that the trash and tire disposal event will be coming June 3rd 4th & 5th, 2025 with the limit of 20 tires per vehicle.

Commissioner Bratton wanted it to be known that he and Commissioner Deans set up camera's at the Hwy 190 barn and no incidents have occurred since they went up.



CLOSED SESSION AT 10:01 AM


