MINUTES:

Minutes from April 12, 2025, were presented and approved with corrections. Commissioner Deans made the motion and Commissioner Bratton seconded. All in favor Motion carries. 5-0

Bills for May 12, 2025, were presented and approved with adjustment for Hanna Concretes bill to be split 3 ways between precincts 2,3,4 from operating expense line item. Commissioner Bratton made the motion and Commissioner Deans seconded. All in favor Motion carried. 5-0 Elected Officials/Department Heads: County Judge Trull reported that the HVAC unit at old Jail has been completed. He also reported that the roof at the County Clerk/Tax Assessor Office is still leaking. Commissioner Deans will be getting report from contractor soon.

DISCUSSION: 1. Discussion regarding beneficial services offered to McCulloch County Veterans through the Menard County Veterans Coalition was presented by Nancy Munetake and Daniel Trimble. The coalition has filed a 501 (C) and is waiting on Tax ID Number. They offer services and local health care to our veterans in surrounding counties of Mason, Junction, Eden, and Menard. Ms. Munetake is the advocate, which is particularly important to the veterans with Dr. Appointments, rides, and filing correct paperwork to help get benefits.

- 10. The Court acted and approved a one-year agreement with the Ener-Tel Services to perform and complete the 2025 Annual Fire Alarm inspection in the amount of \$945.00. Commissioner Bratton made the motion and Commissioner Deans seconded. All in favor Motion carries. 5-0.
- 11. The Court acted and approved a budget amendment to accept TxDOT County Transportation Infrastructure Fund (CTIF) reimbursement for Pct. 1 project 2020-6. It will be received to CTIF grant revenue line item and expend for Pct. 1 purchase of road material. Revenue line 0015.0330.3206 and expense line of 0015.0415.4453 Materials-Repair and Maintenance. Commissioner Anderson made the motion to accept the CTIF reimbursement with Commissioner Young seconded. All in favor Motion carries. 5-0.
