**Elected Officials/Department Heads:** Sheriff Andrews reported to the court that a sewer line that runs through the property of the jail is backed up and bubbling out of sewer hole. Sheriff Andrews thinks the City has it fixed at this time.

Commissioner Anderson reported that TDEM has each point on damaged roads in the precinct #1 marked with estimated damage of \$200,000.00. Commissioner Anderson spoke with Jessica Kramer about emergency repair versus permanent repair.

Commissioner Deans reported that he will be getting his damage documentation in TDEM software this week.

Commissioner Young reported that CR 322 in the area called Lake Ellis, two culverts are draining into several fields, culverts are filled up and he is in the process of replacing both.

County Judge Frank Trull reported that he had a leak in his office from the recent heavy rains. He called Heart of Texas Roofing to repair which they did with some caulking. He also asked them to quote for the County Clerk/Tax Assessor office roof replacement he also spoke to Joey Hardeman Construction for a quote.

**DISCUSSION:** 1. Discussion was held on Road and Bridge material purchases. Precinct #1 Commissioner Anderson has reached the \$50,000.00 threshold and now purchases of additional materials will need to go out for bids. Commissioner Anderson asked the other Commissioners how they felt about the bid process and if they had any concerns. They all agreed that Commissioner Anderson will begin putting together requests for proposals for materials and hauling.

**ACTION:**

1. The Court acted and approved a budget amendment to adjust CTIF funds reimbursement for Precinct 1 project 2020-06 due to overpayment error of grant reimbursement by the Texas Department of Transportation. The amount to be adjusted is \$2,934.48 to be shown as a decrease to revenue line 0015.0330.3206 and expense line 0015.0415.4453. Commissioner Deans made the motion to approve adjustment with Commissioner Bratton seconded. All in favor Motion carries. 5-0.
2. The Court acted and approved to move into Budget Workshop at 9:45 AM. Commissioner Deans made the motion and Commissioner Anderson seconded. All in favor Motion carries. 5-0.

**BUDGET WORKSHOP**

Several key points on the next budget were discussed in the workshop, being whether to fund a veterans service office for McCulloch County or to send funding to the Menard County Veterans Coalition, increase in vehicle stipend for Commissioners and Justice of the Peace, and the additional pay for road hands that hold a CDL.

Having no further business, the meeting adjourned at 1:12 PM with Commissioner Deans making the motion and seconded by Commissioner Bratton. All in favor motion carried. 5-0
