

The Commissioner’s Court of McCulloch County met in Regular Session on the 09<sup>th</sup> Day of June 2025 at 9:00 a.m. with the following present:

Invocation was given by Commissioner Young followed by the Pledge to the U.S. and Texas Flags.

**Public Comment:** Bruce Toeppich addressed the court on rumors and accusations the equipment the he used while employed in Menard County. Mr. Toeppich said he used equipment when his water well went out to water his herd. Mr. Toeppich just wanted his side to be heard, and it be known that comments about him by one of the Commissioners were not true. He did not want to be on the Agenda for Action or Discussion.

**MINUTES:**

Minutes from April 27, 2025, were presented and approved with the correction of the word regular to be changed to special in the first sentence of the minutes. Commissioner Deans made the motion and Commissioner Bratton seconded. All in favor Motion carries. 5-0

**BILLS:**

Bills for June 09, 2025, were presented and approved with Commissioner Young making the motion and Commissioner Bratton seconded. All in favor Motion carried. 5-0

**Elected Officials/Department Heads:** County Commissioner Randy Deans reported on flooded and damaged roads due to the recent heavy rain in Precincts 1 and 2. Texas Department of Emergency Management (TDEM) will be here today Monday June 9<sup>th</sup>, 2025, to assess roads. Commissioner Deans reported that up to 7 roads were not passable but by 5:00 pm Friday all was passable but still in bad shape. County Judge Frank Trull and Commissioner Rod Young of Pct. # 3 also drove the roads in Pct. #2 to access the damage.

County Clerk Christine Jones reported to the Court that with the new Legislative Updates in the Election Laws, there will be several trainings given by the Secretary of State and that her office will be closing for some of the training particularly July 18, 2025, with other dates to follow.

Commissioner Carol Anderson of Precinct #1 reported that McCulloch County had a successful tire and trash disposal event despite the rains. The event had to close early due to reaching capacity in the collection of tires and trash.

County Judge Frank Trull asked Commissioner Deans on the status of Booe Roofing refund for unsatisfactory work done on the County Clerk/Tax Assessor office roof. Commissioner Deans reported that he had not heard anything from Booe but will try and contact them again and have a report in next meeting. Commissioner Young agreed to do request for proposal to replace the roof at the County Clerk/Tax Assessor office. Judge also asked about the status of replacing the ceiling tiles at the AgriLife Extension Office in which Commissioner Deans reported that there was no progress but will go over today to the office. Judge also received maps and documents from Jacob and Martin depicting the completed repairs in relation to the Rochelle Water Supply TDA Grant and want them recorded in the Commissioner Court minutes. He asked County Clerk Christine Jones if he needed to prepare an Agenda Item request or can it be recorded in addition to other RWSC TDA Grant. County Clerk Christine Jones informed County Judge Frank Trull that all the other RWSC TDA Grant documents have already been recorded, and it would be proper to make an Agenda request to get those documents indexed and recorded properly.



**ACTION:**



1. The Court acted and approved a Proclamation for Elder Abuse Awareness month June 2025. Commissioner Anderson made the motion to approve the Proclamation for Elder Abuse with Commissioner Deans seconded. All in favor Motion carries. 5-0.
2. The Court acted and approved the use of the Courthouse Lawn to advertise the 51<sup>st</sup> World Championship BBQ Goat Cookoff from July 21<sup>st</sup>-August 27<sup>th</sup> in the form of a 15 ft. inflatable Goat near the Monument on the south Side Lawn. Daniel Mendoza Chamber Director will let the court know the chamber will inflate and deflate the goat every evening until time to move it to the location of the cookoff. Commissioner Young made the motion and Commissioner Bratton seconded. All in favor Motion carries. 5-0.
3. The Court acted and approved benefits for Medical, Dental, Vision, Basic Voluntary Life, Long Term Disability and Short Term Disability and MASA (Medical Access and Service Advantage). Commissioner Deans made the motion to approve without adding the Employee Self Service Information of Page #4. Commissioner Bratton seconded. All in favor Motion carried. 5-0
4. The Court discussed and approved a Proclamation of Resolution supporting the New World Screwworm Immediate Federal Action to combat the Imminent Threat. Commissioner Anderson made the motion with Commissioner Deans seconded. All in Favor Motion Carries. 5-0
5. The court discussed and approved on CTIF Grant Reimbursement Precinct #1 overpayment of \$2,934.48. Commissioner Anderson made the motion to reimburse the CTIF Grant overpayment in the amount of \$2,934.48 with Commissioner Deans seconded. All in favor Motion carries. 5-0
6. The Court moved to TABLE the proposal to paint/caulk the exterior of the 101 N. High Street County Clerk and Tax Assessor Office until June 23, 2025. Commissioner Deans made the motion to TABLE and Commissioner Bratton seconded. All in favor Motion carries. 5-0.
